### Rebates and incentives for customers on commercial rates

AES Indiana offers rebates and incentives for gualifying new construction, or capital improvement projects. Prescriptive Rebates are available for lighting, HVAC, mechanical, and kitchen equipment.

# **Free upgrades**

Your property may qualify for a variety of no-cost energy-efficient products and services. Professionally installed in-unit upgrades and common area improvements can be made at no cost to you. Products can also be shipped to your property to be installed at your convenience.

### What are eligible upgrades?

When your assessment is completed, AES Indiana will provide your property with a report that identifies available energy upgrades and incentives for your property.

Commonly recommended energy upgrades include:

- → Weather stripping
- $\rightarrow$  Door sweeps
- → High-efficiency showerheads
- → High-efficiency faucet aerators
- → Water heating equipment
- → Heating and cooling equipment
- $\rightarrow$  Pipe insulation
- → ENERGY STAR<sup>®</sup> certified LEDs
- → Programmable or smart thermostats\*

### Eligibility

An active residential customer with eligible AES Indiana service living in a multi-family apartment complex or manufactured home. Properties may not have participated in the program in the last three years to be eligible.



### FAQs

#### Who is eligible for the program?

The AES Indiana multi-family program services are available to residential complexes with 12 or more dwelling units. This includes apartment facilities and manufactured home associations.

#### What does the program offer?

The AES Indiana program offers no-cost services that include:

- → A no-cost energy assessment to identify opportunities for improved energy usage with installation of energy-efficient technologies
- → Installation of selected measures
- → Post-installation follow-up to ensure performance and satisfaction
- → Additional incentives that can help to cover the cost of property improvements for commercially metered customers

#### How can I request services for my multi-family facility?

If you are an authorized representative (i.e., property manager or landlord/owner of the entire facility), you can schedule a no-cost energy assessment by contacting your AES Indiana program consultant at 317-829-0714.

#### Does every unit at my facility need to participate?

Property management is provided with information on the findings from the energy assessment. Property management may choose whether or not to enroll all units and/or to implement any of the measures recommended, but there is no obligation to do so.

# Are there fees for the energy assessment and installation of energy-efficient technologies?

There is no fee to your property for the energy assessment and qualified installation of energy-efficient products.

# Does the program consultant need access to each unit during the assessment?

No, we will only require access to one (1) unit on each unique site, as well as access to common areas.

# What other rebates and incentives are available in addition to those offered through the energy assessment?

For customers on commercial rates, rebates and incentives may be available to help cover the costs of qualifying property, new construction, or capital improvement projects.
